

# REGULATION 2024

(updated January 16<sup>th</sup>, 2024)

**49th edition 100 Km del Passatore 25-26 May 2024.**

**100 Km ROAD RUN, included in the FIDAL National Calendar. The 100 km online route certified by the IAAF / IAU, FIDAL certified.**

IUTA: COMPETITION included in the 21st GRAND PRIX IUTA 2024 of individual and company ULTRAMARATHON.

**ORGANIZATION:** Associazione Sportiva Dilettantistica 100 KM DEL PASSATORE Via Cavour, 7 - 48018 FAENZA (RA) – Telephone 0546/664603 - Email: [info@100kmdelpassatore.it](mailto:info@100kmdelpassatore.it) - La 100 KM DEL PASSATORE takes place according to the rules issued by the FIDAL e dalla I.A.A.F./I.A.U.

**DEPARTURE:** Saturday 25 May 2024 at 3.00 pm in Florence, Piazza Duomo. At 14:45 approach to the start and priority to athletes with significant distance times.

**GATES TIMETABLE:** Gates will be located along the route with the following closing times: 16.6 Km - Vetta le Croci - 6.45 pm (maximum time 3:45); 32 km - Borgo San Lorenzo - 9.15 pm (maximum time 6:15); 48 km - Passo Colla - 1.20 am (maximum time 10:20); 53 Km – Casaglia – 2.10 am (maximum time 11:10); Km 65 - Marradi - 4.30 hours (maximum time 13:30) Km 88 - Brisighella - 9.00 am (maximum time 18:00).

**ARRIVAL:** Faenza, Piazza del Popolo - Conclusion at 11.00 on Sunday 26 May 2024. Maximum time 20 hours.

**RIGHT OF PARTICIPATION:** Anyone who is 20 or older can register. The junior category cannot participate in the race as per FIDAL regulations. Since this is a running event according to FIDAL and IAAF / IAU regulations, participation with other sports equipment is not allowed.

## **REQUIREMENTS FOR PARTICIPATION ATHLETES REGISTERED IN ITALY**

Based on the provisions of the "Rules for the organization of events" issued by FIDAL, athletes registered in Italy in possession of one of the following requirements can participate  
athletes registered in Italy who meet one of the following requirements can participate

- Athletes registered for 2024 for FIDAL affiliated clubs, the age limit of 20 years (promised and senior categories).

- Athletes in possession of Runcard (valid as sports insurance and permission to compete), limited to people aged 20 and over. In any case, participation is subject to: the presentation of a valid medical certificate of specific competitive fitness for athletics, which must be shown to the organizers in original (or the certified copy) and kept, in copy, in the records of the Organizing company of each event. The medical certificate for non-resident foreigners can be issued in one's own country, but the same examinations required by Italian law must have been carried out: a) medical examination; b) complete urinalysis; c) electrocardiogram at rest and after exertion; d) spirometry.

- Athletes registered with a Sports Promotion Body (Athletics Section), in possession of Runcard-EPS; participation is however subject, in addition to the possession of the "RUNCARD":

to the presentation of a medical certificate of specific competitive fitness for athletics, currently valid, which must be shown to the organizers in original (or the authenticated copy) and kept, in copy, in the records of the organizing company of each event. The medical certificate for non-resident foreigners can be issued in one's own country, but the same examinations required by Italian law must have been carried out: a) medical examination; b) complete urinalysis; c) electrocardiogram at rest and after exertion; d) spirometry.

### **PARTICIPATION REQUIREMENTS FOR ATHLETES NOT REGISTERED IN ITALY**

Italian / foreign athletes not registered in Italy, in possession of one of the following requirements, can participate:

- Athletes with club cards affiliated to Foreign Athletics Federations recognized by the IAAF, the age limit of 20 years (promised and senior categories). Upon registration, they must alternatively present: the self-certification of possession of the card recognized by the IAAF. The self-certification will then, however, be signed in original upon collection of the bib. Athletes in possession of Runcard (valid as sports insurance and permission to compete), limited to people aged 20 and over; participation is however subject, in addition to the possession of the "RUNCARD": to the presentation of a medical certificate of specific competitive fitness for athletics, currently valid, which must be shown to the organizers in original (or the authenticated copy) and kept, in copy, in the records of the organizing company of each event. The medical certificate for non-resident foreigners can be issued in one's own country, but the same examinations required by Italian law must have been carried out: a) medical examination; b) complete urinalysis; c) electrocardiogram at rest and after exertion; d) spirometry.

**DISABLED ATHLETES:** For the safety problems of the athletes it is not possible to participate with handbikes.

### **ASSOCIATIVE REGISTRATION FEE:**

- from 15 January 2024 until 15 March 2024 € 80,00 (+ € 7.00 option to change "Casaglia" clothes);
- from 16 March 2024 until 15 April 2024 € 110,00 (+ € 7.00 option to change "Casaglia" clothes);
- from 16 April 2024 until 15 May 2024 € 130.00 (+ € 7.00 option to change "Casaglia" clothes);
- the cost of transferring the registration fee to 2025 is € 15.00 (Payment must be made when registration opens 2025 and sent together with the registration form 2025). The request for the transfer of the fee must be made by sending an e-mail request until March 31, 2024. From April 1 to May 11, 2024 it is mandatory to present a medical certificate certifying the inability to participate in the tender.
- The transfer of the bib to another competitor is possible by paying the secretarial fees of € 15.00 by 11 May 2024.

Registrations are not accepted without the eventual payment of the fee.

Italian and foreign athletes residing in Italy must present:

a photocopy of the provisional FIDAL card valid for the year 2024 issued by the sports club to which it belongs with indication of the expiry date of the medical certificate valid for the event, or a

photocopy of the Runcard Fidal and the medical certificate of competitive fitness (D.M. 18/02 / 82 and 28/02/83) to athletics valid as of 26/05/2024.

**TRANSFER OF THE PARTICIPATION FEE FROM 2022 TO 2024:** At the opening of the registration in 2024 it is necessary to present all the documentation for the new registration and to pay a supplement for secretarial rights of € 15.00 (by 28 February 2024).

**GROUPS:** For groups there is a free fee in case of cumulative registration of 20 athletes (the 21st registration is free). Dues must be sent in a single payment.

### **SIGNING UP:**

**We do not accept registrations without the membership fee and the medical certificate of competitive sporting fitness (Ministerial Decree 18/02/82 and 28/02/83) for the runcard and provisional card in case of Fidal membership. If the medical certificate expires before the event, the new valid document must be sent by 15 May 2023.**

Registrations must be made strictly by 11 May 2024 at: - A.S.D. 100 km of the Passatore, Via Cavour, 7 - Faenza (Telephone 0546/664603); - The Isolotto dello Sport, Via dell'Argin Grosso, 69 a / b - Florence (Tel. 055/7331055).

**RESPECT FOR THE ENVIRONMENT:** Given the report by the municipal administration following the events that occurred in the past edition of the race, concerning the uncivilized behavior of some athletes to the detriment of the decorum of the city, it was necessary to review our logistics, in particular in the urban center areas, and part of the regulation.

In Florence, the bib delivery and related services have been moved to Viale Abramo Lincoln (Cascine area) on the Lungarno side of Vittoria bridge and a "Runner's Village" has been set up where they will be available to athletes: spaces for changing clothes and for massages, the health station managed by Misericordia Firenze, chemical toilets, buses for the delivery of clothing bags and all the Organization's stands.

The area will be accessible to runners and carers from 10:30 am to 2:00 pm on the day of the race, and parking is possible nearby.

You can reach the starting point in Piazza Duomo either on foot or via Tramvia 1 (three stops, about 7 minutes) and the directions will be provided both in the race packet and in the Organization's stands, as well as on the website. It is advisable to stay in the village area up to a time as close as

possible to departure, as there are no other meeting points along the way from the village to Piazza Duomo. It is absolutely forbidden to change clothes or carry out any preparation activities for the race outside the village (massages, use of oils or creams, or other).

It should be noted that in agreement with the Municipal Administration, the sanctions for uncivilized behavior and to the detriment of the dignity of the city within the historic center of Florence have been reinforced. Violation of these rules will be punishable by law by the Municipal Police, and **will result in disqualification from the race** even in the event of reporting by the FIDAL judges, internal judges or other staff of the Organization.

In Florence, in Piazza Duomo, there will be chemical toilets located in the area adjacent to the entrance to the starting cage.

We remind you that along the route of the race (Florence - Faenza) it is forbidden to throw waste outside the refreshment areas, where there will be special bins.

We try to respect the environment and other people.

### **PROHIBITION OF CROSSING OF CLOSED LEVEL PASSAGES:**

- It is strictly forbidden for participants to cross the 6 level crossings present along the race course when the bars are lowered for the passage of trains (6 trains will pass during the race);

### **PROHIBITION CAR / MOTORCYCLE:**

- Participants are strictly prohibited from getting on any vehicle / vehicle, and the transport of any participant by third parties is strictly prohibited. Violation of this article will result in the immediate disqualification of the competitor;

- Participants are prohibited from receiving any assistance (excluding medical and / or physiotherapy treatment), outside the authorized areas (usually refreshments or medical points). The violation of this article will result in disqualification of the competitor;

- No vehicles are allowed to accompany the athlete, assistance is prohibited outside the authorized areas (usually refreshments or medical points);

- To avoid damage to competitors resulting from carbon monoxide fumes and traffic jams, A PROHIBITION OF PARKING AND STOPPING HAS BEEN ESTABLISHED at PASSO VETTA CROCI and PASSO COLLA. Municipal Police personnel will be present to enforce this requirement.

**REMEMBER THAT THE BEAUTY OF THIS RACE CAN ONLY BE KEPT IF EVERYONE RESPECTS THE RULES!**

**GROUPS:** The "groups" are intended only if made up of at least six participants. It is necessary to declare the list of athletes at the time of registration.

**BIBS:** The bibs can be collected by the participants, upon presentation of the confirmation of the registration that can be printed from the [list of participants](#) and an identity document, from May 20 to 23, 2024 from 9:00 to 12:00 and from 15:00 to 19:00 and by reservation only on May 24 from 9:00 to 19:00 at the headquarters of the Organization, in FAENZA in Via Cavour, 7.

For those who have not done so before, it will be possible to collect the bib **from 10.30 to 14.00 on Saturday 25 May 2024 in Viale del Fosso Macinante (Tamburello, Cascine area) - FLORENCE.**

**IMPORTANT!! Competitors are obliged to wear the bib clearly in view, since the disposable chip is applied on the back of the same; not to reduce the size or hide any imprinted words or symbols, under penalty of exclusion from the Race.**

**During the night it is mandatory to wear reflective bands or have an electric battery.**

**COURSE:** The course officially measures 100 kilometers, as tested by the IAAF / IAU; the route unfolds on the state and provincial roads from Florence-Fiesole-Borgo San Lorenzo-Faenza and is completely asphalted. Signals every 5 km plus the "marathon pass" sign.

**SERVICES:** Every 5 km approximately, along the route and upon arrival, free refueling stations will be set up for the distribution of comfort items. Spraying and sponging areas are also planned up to Borgo San Lorenzo.

**COMPETITORS TRANSPORT:** Saturday 25 May 2024, at 8:30 am, in FAENZA in front of the PalaBubani (Piazzale Pancrazi 1) for the departure buses will be available, ON RESERVATION (online, fax or e-mail) for the transport of athletes in FLORENCE for the start of the race, the cost is € 20.00.

**BIKE TRANSPORT:** Saturday 25 May 2024 - service fee € 5.00.

**The bicycles, previously labeled with the name and surname of the owner, will be transported with a truck that will leave after the departure of the last bus, from Faenza (PalaBubani, Piazzale Pancrazi 1) and must be collected by presenting an identity document from 11:30 to 12:00 in Viale del Fosso Macinante (Tamburello, Cascine area) in Florence.**

Bicycles not collected by this time will be returned to the deposit of the Transport Cooperative of Riolo Terme (RA) as the truck cannot park for a long time in this square.

**GARMENT TRANSPORT SERVICE:** A truck directed from Florence to Faenza will transport the bags / bags of the competitors from the bib collection point in Florence to the garment tent in Piazza del Popolo in Faenza. There is also the possibility of transporting clothes, to make an intermediate change of clothes in Casaglia, at km 53, (option at a cost of € 7.00 to be exercised at the time of registration). A special bag for the intermediate change will be included in the race package which must be delivered in special containers, divided by bib number, located in Florence in Viale del Fosso Macinante (Tamburello, Cascine area). The "change clothes" bags used by the competitors before 11.30 pm will be loaded on a special truck and will then be available for collection at the clothing tent in Faenza in Piazza del Popolo after 1.30 am on Sunday 26 May 2024. "intermediate change" bags not used in Casaglia will be loaded on a special truck and taken to Faenza after the Casaglia gate is closed and will then be available for collection at the clothing tent in Faenza in Piazza del Popolo after 4:30 on Sunday May 26, 2024.

**CHECKS:** At the start, along the route and at the checkpoints, participants must pass on special "platforms" prepared for the detection of the chip code. Competitors who have not passed on said "platforms", or for which unreliable times on the distance between one control and the other will be recorded, will be disqualified. According to the FIDAL provisions, doping control will be carried out.

**LOGISTICS:** Medical assistance and first aid service are guaranteed in the following locations: Florence, Saletta, Fiesole, Vetta le Croci, Polcanto, Faltona, Borgo San Lorenzo, Ronta, Razuolo, Colla di Casaglia, Casaglia, Crespino, Marradi, Sant'Adriano, San Cassiano, Strada Casale, Fognano, Brisighella, Errano, Faenza; massages: Vetta le Croci, Borgo San Lorenzo, Razuolo, Colla di Casaglia, Casaglia, Marradi, San Cassiano, Fognano, Brisighella, Errano, Faenza, G.Lucchesi gym. The recovery and transport service for withdrawn competitors is also ensured. Through the radio emergency service it is possible to connect with all the services made available by the organization. Refreshments located along the route every 5 km. Florence-Faenza railway line with stations at: Borgo San Lorenzo, Panicaglia, Ronta, Crespino, Biforco, Marradi, Popolano, S. Martino in Gattara, San Cassiano, San Eufemia, Strada Casale, Fognano, Brisighella, Faenza.

**RANKINGS: GENERAL - MEN - WOMEN. GROUPS,** a ranking will be drawn up based on the number of competitors arrived (in the event of a tie, the best total time achieved will be taken into account) and a ranking by counting the average of the times of the first six finishers. The measurement of the times and the processing of the rankings is by SDAM S.r.l., the same are validated by the Technical Delegate or the Appeals Judge.

**AWARDS:** Medal and diploma for participation in the goals (not cumulative) of Borgo San Lorenzo, Colla di Casaglia, Marradi, FAENZA. TO ALL ARRIVED IN FAENZA, THREE BOTTLES OF WINE OF ROMAGNA DEL PASSATORE ("Wines of the Passatore: the wines of welcome and goodbye").

The competitor who passes first at the 48th kilometer and then reaches the final finish line in Faenza, will receive a refund of € 300.00. BONUS R.S. of € 500.00 if the race record is broken: Men 6.25.46 - Women 7.34.36. The prizes are net of any withholding taxes. 25% of the prize pool is reserved for Italian athletes. No cash prizes (or similar cases: generic value vouchers, bonuses, engagements, reimbursement of expenses of any kind and for any reason) for "Runcard" owners. The disbursement of cash prizes takes place in accordance with the rules of World Athletics and the laws of the Italian State.

The awarding of the first 5 arrivals, the first 5 women and the first 3 groups will take place at 10.00 on Sunday 26/05/2024 in the Piazza del Popolo in Faenza. From 11th position, any prizes can be collected after 45 minutes from the display of the rankings. Unclaimed prizes will remain available to competitors at the Secretariat of the 100 Km (Via Cavour, n ° 7 - 48018 Faenza) until 31 October 2024; after that date they will become part of the prize pool of the 2025 edition of the 100 Km del Passatore. Any other prizes will be announced upon arrival in Piazza del Popolo in Faenza and drawn from the competitors.

**G.P. MOUNTAIN:** Francesco Calderoni Award (1st man) and Angela Bettoli (1st woman). A ceramic prize will be awarded, offered by U.O.E.I. of Faenza, to the competitor who will pass in first position at Passo della Colla and will then reach the final finish line in Faenza.

**COMPLAINTS:** Any complaints, accompanied by the fee of € 100.00, refundable in case of acceptance, must be presented in compliance with the rules of FIDAL and R.T.I..

**"I WAS THERE":** A special prize "I was there" (established in 1977) in traditional Faenza ceramic is awarded at the finish line to athletes who have completed 5, 10, 15, 20, 25, 30, 35, 40, 45 races. Unclaimed prizes are sent on request with shipping costs to be paid by the competitor.

**JUDGE OF APPEAL:** the Appeals Judge oversees the technical application of this regulation: imposes sanctions, examines appeals. His judgment is final and unappealable.

**RESPONSIBILITY:** The Organization, while taking care of the success of the Event, declines all responsibility for any damage or injuries that may occur to Competitors, third parties and things, before, during and after the event and any responsibility for valuables and money left on stock exchanges.

**FAILURE TO CARRY OUT:** If the tender is canceled, or not held, for reasons not attributable to the Organization, including the revocation of the authorization to carry it out by the competent Public Bodies, the member must have nothing from the 100 Km del Passatore A.S.D. by way of reimbursement of the costs incurred for registration as the signing of the registration application also counts as a waiver of any claim for compensation for damage or compensation or any satisfactory claim for any financial damage suffered.

By registering for the race, the competitor **DECLARES** to know and accept the regulation of the 100 Km del Passatore, to be 20 years old; to know that participating in a 100 km is potentially a risky activity and that you cannot register if you are not physically fit and adequately prepared and

declares to be in possession of a suitable valid sports medical certificate. He also declares to register voluntarily and to assume all the risks deriving from his participation in the race: falls, accidents of any kind, weather conditions. **RELIEF** and **RELEASE** the 100 Km del Passatore Amateur Sports Association, the promoters, the sponsors and all those connected to them, of all present and future claims or responsibilities of any kind deriving from its participation in the event unless this responsibility it does not derive from some negligence or error of theirs. Once the registration to the 100 Km del Passatore has been accepted, the participation fee is not refundable. The competitor also grants his authorization to all the entities listed above to use photographs, tapes, videos and anything related to his participation in the event for any legitimate use without remuneration. Personal data will be treated in compliance with law 675/96.

### **FINAL WARNINGS**

The Organizing Committee reserves the right to modify these regulations at any time for reasons it deems appropriate for a better organization of the race, after having communicated and obtained approval from FIDAL. For anything not provided for in this regulation, the technical statutory regulations of FIDAL and G.G.G are valid. Any changes to services, places and times will be appropriately communicated to the registered athletes or will be reported on the website [www.100kmdelpassatore.it](http://www.100kmdelpassatore.it) In addition, the documentation containing the information essential to take part in the race will be delivered by the organization together with the bib.
